- (2) **CPP ACQUISITION GROUP INC** a corporation organised and formed on 18<sup>th</sup> March 1996 under the Laws of the State of Illinois, United States of America and having an office for the conduct of business at 89 O'Leary Drive, Bensenville, Illinois ("CPP")

**WHEREAS**

- (A) Macfarlane is the beneficial owner of the registered trade mark ("the Trade Mark") detailed in the Schedule annexed to and which shall be deemed to form part of this Agreement; and
- (B) Macfarlane and CPP entered into an agreement dated 3<sup>rd</sup> May 2002 ("the Asset Transfer Agreement") for the transfer from Macfarlane to CPP of certain equipment, patents and the Trade Mark, with effect from that date ("the Effective Date").

NOW IT IS HEREBY AGREED as follows:-

1. **Assignment**

- 1.1 In consideration of the sum of One Dollar (\$1) set forth in the Asset Transfer Agreement, Macfarlane hereby assigns to CPP absolutely with effect from the Effective Date irrespective of the date or dates of signature of this Assignment the Trade Mark and all and any rights in and to the Trade Mark, including all statutory and common law rights attaching thereto and the right to sue for past infringements, and Macfarlane confirms that this Assignment is made with the goodwill attaching to the Trade Mark;

2. Further Assurance

2.1 Macfarlane hereby undertakes to CPP that Macfarlane will at the expense of CPP do all such acts and execute all such documents as may reasonably be required by CPP to enable CPP to enjoy the full benefits of the rights hereby assigned.

3. General

3.1 The parties certify that this Assignment comprising a transfer of intellectual property is exempt from stamping in terms of Section 129 of the Finance Act 2000.

4. Governing Law

4.1 This Assignment shall be governed by and interpreted in accordance with the laws of Scotland and the parties hereby submit to the non-exclusive jurisdiction of the Scottish Courts.
