TRADEMARK ASSIGNMENT

WHEREAS, Kaul Tronics, Inc., a Wisconsin corporation (hereinafter "Assignor"), has adopted, used and is using a trademark which was registered in the U.S. Patent and Trademark Office on December 23, 1997 as Registration No. 2,124,382 (the "Mark"); and

WHEREAS, Assignor and California Amplifier, Inc., a Delaware corporation (hereinafter "Assignee"), have entered into a certain Asset Purchase Agreement dated April 5, 2002 (the "Asset Purchase Agreement"), by and among Assignor, NGP, Inc., a Wisconsin corporation ("NGP"), Interactive Technologies International, L.L.C. ("ITI"), and Assignee, under which Assignee has agreed to purchase and Assignor has agreed to sell to Assignee the Mark and the registration thereof.

NOW, THEREFORE, pursuant to the terms and conditions as provided in the Asset Purchase Agreement, and other good and valuable consideration, the receipt of which by Assignor from Assignee is hereby acknowledged, Assignor hereby sells, assigns, and transfers to Assignee all of its right, title and interest in the Mark referred to above, together with all goodwill associated therewith.


Absent express authorization by Assignee, Assignor agrees to refrain from the use of the Mark in any way and for any purpose or to use in commerce any other Mark in connection with the sale, offering for sale, distribution, or advertising of any goods or services when such use is likely to cause confusion, or to cause mistake, or to deceive any party as to the source of any goods and services offered by Assignor or as to the sponsorship of Assignor, its business, products, or services. The waiver by Assignee of a breach by Assignor of this section shall not operate or be construed as a waiver of any subsequent breach by Assignor. Any use of the Mark by Assignor, under the terms of this section or otherwise, shall inure to the benefit of Assignee.


