THIS ASSIGNMENT (hereinafter "Assignment") is entered into this 31st day of January, 2002, by and among **INSTY-PRINTS, INC.**, a Minnesota corporation, **IPI, INC.**, a Minnesota corporation (hereinafter each referred to as an "Assignor" and together as "Assignors"), and **ALLEGRA HOLDINGS LLC**, a Michigan limited liability company (hereinafter "Assignee"). All capitalized terms used but not defined in this Assignment will have the meaning ascribed to them in that certain Asset Purchase Agreement dated November 15, 2001 by and among Assignee and Assignors (hereinafter "the Agreement").

WHEREAS, Assignors may have certain rights in and to issued domestic and foreign patents, patent applications, patent applications in process, trademarks, trademark registrations, trademark registrations applications, service marks, service mark registration applications, service mark registrations, copyrights, copyright registrations, copyright registration applications, license agreements, logos, trade names, slogans, know-how, proprietary information and trade secrets which are presently used in and/or necessary to conduct the Business, including, without limitation, the trademarks and services marks described on Schedule A hereto (the "Trademarks") and the copyrights described on Schedule B hereto (the "Copyrights") (all of the foregoing are hereinafter referred to as the "Intellectual Property");

WHEREAS, pursuant to the Agreement, Assignee shall acquire whatever right, title and interest in, to and under the Intellectual Property that each Assignor currently possesses.

NOW, THEREFORE, pursuant to the Agreement and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

1. Each Assignor does hereby sell, assign, transfer and set over to Assignee all its right, title and interest in, to and under the Intellectual Property, together with all rights and privileges granted and secured thereby (and the goodwill of the business symbolized by any marks or names), including the right to sue and recover for any past violation, said rights to be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by such Assignor if this Assignment and sale had not been made.


