

Release of Security Interest in and Assignment of Intellectual Property

This RELEASE OF SECURITY INTEREST IN AND ASSIGNMENT OF INTELLECTUAL PROPERTY (the "Release") is effective as of July 3, 2002.

WHEREAS, Bank of America, N.A. (as "Lender") and SPACELABS MEDICAL, INC., a Delaware corporation ("Spacelabs Delaware"), SPACELABS MEDICAL, INC., a California corporation, SPACELABS BURDICK, INC., a Delaware corporation, VITA-STAT MEDICAL SERVICES, INC., a Florida corporation, LIFECLINIC MEDICAL DATA CORPORATION, a Washington corporation, and LIFECLINIC.COM CORPORATION, a Washington corporation (collectively, "Borrowers"), entered into a Credit Agreement dated January 16, 2002 (as amended, supplemented or otherwise modified from time to time, and together with all exhibits, schedules, documents and instruments ancillary thereto, the "Credit Agreement");

WHEREAS SPACELABS PRODUITS MEDICAUX LTEE, a Quebec Company (the "Guarantor") entered into a Guaranty dated January 16, 2002 on behalf of Borrowers and in favor of Lender;

WHEREAS Borrowers and Guarantor (collectively "Grantors") and Lender entered into a Security Agreement dated January 16, 2002 (as amended, supplemented or otherwise modified hereafter from time to time, the "Security Agreement"), a Trademark Security Agreement dated January 16, 2002 (as amended, supplemented or otherwise modified hereafter from time to time, the "Trademark Security Agreement"), and a Patent Collateral Assignment Agreement (as amended, supplemented or otherwise modified hereafter from time to time, the "Patent Security Agreement" and collectively, with the Security Agreement and the Trademark Security Agreement, the "IP Security Agreements"), pursuant to which Grantors granted Lender a security interest in all of Grantors' right, title and interest in and to the patents and patent applications listed on Schedule A hereto ("Patents") and the trademarks, trademark applications and trademark registrations listed on Schedule B hereto ("Trademarks");

WHEREAS the IP Security Agreements were filed with the United States Patent and Trademark Office with respect to Patents;

WHEREAS the IP Security Agreements were filed and recorded in favor of Lender in the United States Patent and Trademark Office on January 18, 2002 at Reel No. 002425 and Frame No. 0518 with respect to Trademarks; and

WHEREAS, in accordance with the provisions of the Amendment and Consent dated as of July 3, 2002 among Grantors and Lender, the Lender is willing to release and discharge fully its right, title and interest in and to the Patents and Trademarks as set forth below:

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender agrees as follows:

1. Lender does hereby irrevocably terminate and release its security interest in, lien on, hypothec, collateral assignment of and right of set-off against, in and to the Trademarks,

including without limitation all renewals thereof, all proceeds of infringement suits, the right to sue for past, present and future infringements and all rights corresponding thereto throughout the world, and the goodwill of the businesses to which each Trademark relates.

2. Lender does hereby irrevocably terminate and release its security interest in, lien on, hypothec, collateral assignment of and right of set-off against, in and to the Patents, including without limitation, all proceeds thereof (such as by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof.

3. Lender hereby grants and conveys back to Grantors all of Lender's right, title and interest in and to Patents, including without limitation, all proceeds thereof (such as by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, as previously granted to Lender by Grantors in the Patent Security Agreement.

4. This Release may be executed in one or more counterparts, each of which when executed shall be deemed an original but all of which taken together shall constitute one and the same agreement. Copies of executed counterparts transmitted by telecopier or other electronic transmission service shall be effective as delivery of an original executed counterpart of this Release.


5. This Release shall be governed by and construed in accordance with the laws of the State of New York, except to the extent that the release of security interest hereunder is governed by the laws of a jurisdiction other than the State of New York.

6. Lender hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office and any other applicable governmental officer to record this Release.
