**RELEASE AND REASSIGNMENT
OF
TRADEMARK SECURITY INTEREST**

WHEREAS, eMed Technologies Corporation (formerly known as "ACCESS Radiology Corporation"), a Delaware corporation (the "Company"), represents that it owns the registered trademarks described in the attached Exhibit A (the "Trademarks"), for which recordings are filed in the United States Patent and Trademark Office under the numbers set forth in the attached Exhibit A;

WHEREAS, pursuant to that certain Security Agreement (Trademarks) dated as of September 30, 1999 (the "Agreement"), the Company granted a security interest in the Trademarks to Fleet National Bank ("Fleet") to secure performance by the Company of its obligations to Fleet under an Inventory, Accounts Receivable and Intangibles Security Agreement (and a related letter agreement, as amended, between Fleet and ACCESS Radiology Corporation), dated as of May 16, 1997, as amended given by said ACCESS Radiology Corporation to Fleet;

WHEREAS, the Agreement was recorded in the Assignment Branch, United States Patent and Trademark Office, on October 3, 1999, located on Reel 001977, Frame 0312; and

WHEREAS, the Company has paid and performed in full its obligations to Fleet and terminated all further obligations of Fleet to extend credit to the Company and its affiliates;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Fleet hereby terminates all of its right, title and interest in, to and under the Trademarks and reassigns and reconveys (without warranty of any sort) to the Company all of its right, title and interest in the Trademarks and all the good will of the business symbolized by the Trademarks, together with the application, registration and recordings in the United States Patent and Trademark Office, and all reissues, extensions or renewals thereof, together with the right to sue and recover damages for future infringements thereof and all other rights of Fleet in all matters related thereto.

The parties hereto have caused this Release and Reassignment of Trademark Security Interest to be executed this 26 day of February, 2002.
