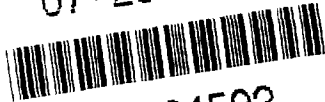

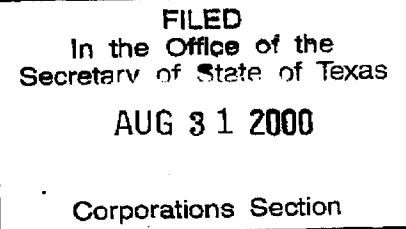

TO THE
AMENDED ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Amended Articles of Incorporation:

ARTICLE THREE


The number of shares of the corporation outstanding at the time of such adoption was 10,000; and the number of shares entitled to vote thereon was 10,000.
