WHEREAS, Bollinger is the assignee of the trademark ROCK BARBELL & FITNESS and design for which the following registration has issued and application was made:



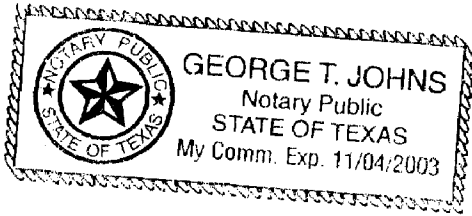
