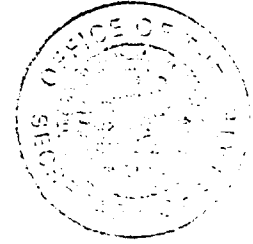

1. They are the president and secretary, respectively, of Stone Products, a California Corporation (the "Corporation"). ↑ Corporation

2. Article One of the Restated Articles of Incorporation of the Corporation is amended to read as follows:

ONE: The name of this corporation is Cultured Stone Corporation.

3. The foregoing amendment of the Restated Articles of Incorporation has been duly approved by the Board of Directors of the Corporation.


4. The foregoing amendment of the Restated Articles of Incorporation of the Corporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the Corporations Code. The Corporation has three classes of shares outstanding, Common Stock, Series A Convertible Preferred Stock and Series B Convertible Preferred Stock, each of which is entitled to vote with respect to the amendment herein set forth. The number of outstanding shares of Common Stock is 24,000. The number of outstanding shares of Series A Convertible Preferred Stock is 56,000. The number of outstanding shares of Series B Convertible Preferred Stock is 8,888. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required for the approval of the amendment herein set forth was more than fifty percent (50%) for each class of shares of the Corporation.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this Certificate of Amendment are true and correct of our own knowledge.

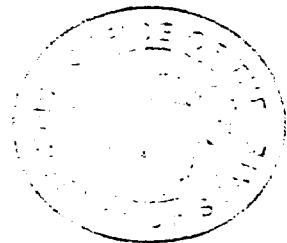

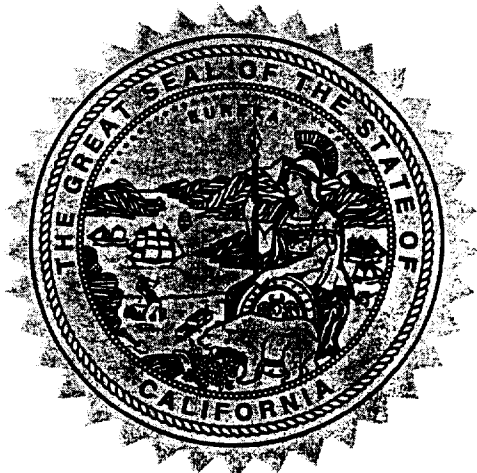
