INTELLECTUAL PROPERTY TRANSFER AGREEMENT

This Agreement is made as of this 15th day of March 2002, by and among Edwards Systems Technology, Inc., a Connecticut corporation ("Edwards") and Dukane Corporation, a Delaware corporation ("Dukane").

For good and valuable consideration, receipt of which is hereby acknowledged, and pursuant to the agreements and obligations of Dukane under the Asset Purchase Agreement by and among Edwards, SPX Canada, Inc. and Dukane (the "Purchase Agreement"), subject to Dukane's rights under the terms of the License Agreement and the IP License, Dukane hereby assigns, conveys and transfers to Edwards all of the Intellectual Property, as defined in the Purchase Agreement, that is among the Assets conveyed to Edwards under the Purchase Agreement. As provided in the Purchase Agreement, subject to Dukane's rights under the terms of the License Agreement and the IP License, such Intellectual Property includes, but is not limited to: (a) the Trademarks and Patents (including, without limitation, the applications therefor) listed in Attachment A hereto; (b) the right to sue at law, or in equity, for any infringement or other impairment of the Intellectual Property, including the right to collect damages, including, without limitation, past damages, and proceeds therefrom; and (c) the goodwill pertaining to the Trademarks, including, but not limited to, "Dukane."


All capitalized terms not defined herein shall have the meanings given to such terms in the Purchase Agreement.
