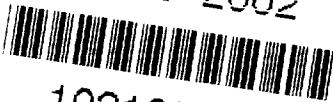

## INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT, dated as of 9:00 A.M., Pacific Daylight Time, July 1, 2002, by and between Texaco Inc., a Delaware corporation ("Assignor"), and Chevron U.S.A. Inc., a Pennsylvania corporation ("Assignee"), (and, together with Assignor, the "Parties" and each, individually, a "Party").

WHEREAS, pursuant to a restructuring, Assignor desires to transfer and assign and Assignor desires to assume certain intangible assets owned and used by Assignor in the conduct of its commercial business (the "Business"); and

WHEREAS, Assignor owns, and has adopted for use in the Business: (a) the United States registered trademarks, service marks and pending trademark applications listed on the attached Schedule A, and all other United States trademarks, trade names, trade dress and service marks, whether registered or unregistered that are associated with the Business, together with the registrations and applications therefor (collectively, the "Marks") and (b) interests in the registered and unregistered copyrights worldwide relating to or arising out of the Business, including those registered copyrights listed on the attached Schedule B (the "Copyrights") (collectively, the Marks and Copyrights are hereinafter referred to as the "Intellectual Property"); and

WHEREAS, Assignee is desirous of acquiring the entire right, title and interest in, to and under the Intellectual Property as of July 1, 2002.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignor hereby conveys, transfers and assigns to Assignee, all right, title and interest in and to the Intellectual Property, together with all rights of action accrued, accruing and to accrue under and by virtue hereof, including the right to sue or otherwise recover for past infringement and receive all damages, payments, costs and fees associated therewith, all subject to their respective terms and conditions and including any obligations to third parties under which such rights may be held. The assignment of the Marks granted herein includes the goodwill of the business symbolized by the Marks. The assignment of the Copyrights granted herein includes the right to secure renewals and extensions of such copyrights throughout the world, for the full term of said copyrights and any renewal extensions of same that are or may be granted throughout the world in the Copyrights, and any embodiments necessary for the exercise of such Copyrights or derivative works thereof.

2. Assignor hereby agrees to execute all such documents as may be required to transfer and, when applicable, to record the transfer of the Intellectual Property.

3. This Intellectual Property Assignment constitutes the entire understanding and agreement between the parties and supersedes all prior proposals, agreements and



representations between them, whether written or oral, with respect to the subject matter hereof.
