**WHEREAS**, Assignor entered into a Bill of Sale, Assignment and Conveyance dated May 16, 2002 (the "Agreement") pursuant to which Assignor has agreed to sell certain of Assignor's assets relating to its business that bear certain registered servicemarks or in which Assignor uses registered trademarks (the "Business") and became obligated under the Agreement to convey such registered trademarks to Assignee.

**NOW, THEREFORE**, for the sum of \$1.00 and for other good and valuable consideration, the receipt and sufficiency of which are acknowledged, Assignor hereby grants, conveys and assigns to Assignee all right, title and interest it may have in and to all of the trademark and servicemark registrations listed on Schedule 1 hereto (the "Marks") together with (i) the goodwill of the Business related to such use and symbolized by the Marks, (ii) renewals of the Marks, (iii) all income, royalties, damages and payments now and later due and payable with respect to the Marks including, without limitation, damages and payments for past, present or future infringements, (iv) the right to sue for past, present and future infringements, and (v) all rights to such Marks throughout the world.

Assignor makes no representation or warranty with respect to the protectability from use by others of the Marks, and Assignee, by its acceptance of this Assignment, acknowledges that his Assignment constitutes only a quitclaim of Assignor's rights, title and interest, if any, in and to the Marks and associated goodwill and contains no representation or warranty with respect to such right, title or interest.

Assignor covenants that it will execute any other documents and perform any other acts that may be necessary to fully vest in Assignee the rights conveyed by this Assignment. When information is brought by Assignee to Assignor's attention that others are infringing on the rights granted to Assignee under this Assignment, Assignor shall (at Assignee's cost and expense) cooperate with and assist Assignee in protecting those rights.

This Assignment shall be binding upon Assignor, its successors and assigns, and shall inure to the benefit of Assignee, its successors and assigns.

This Assignment shall be deemed to have been executed and delivered in the State of Connecticut, and shall be governed by and construed in accordance with the internal laws, as opposed to rules governing conflicts of laws, of the State of Connecticut.


