THE FIRST NATIONAL BANK OF BOSTON, as agent (in such capacity, the "Agent") for (a) THE FIRST NATIONAL BANK OF BOSTON, FEDERAL DEPOSIT INSURANCE CORPORATION, as Receiver of New Bank of New England, N.A., as Assignee of Federal Deposit Insurance Corporation, as Receiver for Bank of New England, N.A., CHEMICAL BANK (successor by merger to Manufacturers Hanover Trust Company) and THE CHASE MANHATTAN BANK, N.A. on the one hand (collectively, the "Dollar Banks"), and (b) FLEET PRECIOUS METALS INC., RHODE ISLAND HOSPITAL TRUST NATIONAL BANK, REPUBLIC NATIONAL BANK OF NEW YORK and ABN AMRO BANK N.V., New York Branch (collectively, the "Gold Banks") (the Dollar Banks and the Gold Banks collectively, the "Lenders");

W I T N E S S E T H:

WHEREAS, pursuant to the Trademark Collateral Agreement dated as of November 8, 1991, by and among the Company, the Lenders and the Agent, the Company has granted to the Agent, BY WAY OF COLLATERAL SECURITY, all of the Company's right, title and interest in and to the trademarks, service marks, trademark and service mark registrations, and trademark and service mark registration applications listed on Schedule 1 attached hereto (the "Marks"); and

WHEREAS, the Company is desirous of acquiring all of the Agent's right, title and interest in and to the Marks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent, on behalf of the Lenders, does hereby assign (without warranty of title or any other representation or warranty and without recourse, all of which are expressly disclaimed) to the Company, all of the right, title and interest, if any, of which it may be possessed, in and to the Marks, together with the goodwill symbolized thereby and the registrations thereof, together with the right to sue for any past infringements.
