REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is made as of July 19, 2002 by COMERICA BANK-CALIFORNIA, as successor in interest to IMPERIAL BANK ("LENDER") to CELEBRATEEXPRESS.COM, INC., a Washington corporation, with its principal place of business at 11220 120th Avenue NE , Kirkland, WA 98033 ("COMPANY").

Recital

WHEREAS, COMPANY assigned certain interests in the trademarks described on Exhibit A-1 and Exhibit A-2 (collectively, the "Trademarks") to LENDER under an Intellectual Property Security Agreement dated as of October 6, 2000 and recorded with the U.S. Patent and Trademark Office on November 16, 2000 at Reel Number 002192 and Frame Number 0646 with respect to the Trademarks on Exhibit A-1; and again on April 1, 2002 at Reel Number 002472 and Frame Number 0409 with respect to the Trademarks on Exhibit A-2; and
