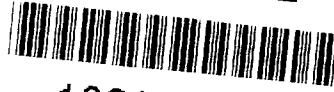


RESOLVED, that Schlage Lock Company assumes all of the obligations of Kryptonite Corporation pursuant to Section 1110 of the California Corporations Code.
