ASSIGNATION

THIS ASSIGNATION is made this 24TH day of May 2002

BETWEEN

- 1) White Heather Distillers Limited,
of House of Campbell, West Byrehill, Kilwinning, Ayrshire, KA13 6LE
(hereinafter called "the Assignor");

AND

- 2) Chivas Brothers Limited,
of 111/113 Renfrew Road, Paisley PA3 4DY
(hereinafter called "the Assignee").

WHEREAS

The Assignor is the applicant for or registered proprietor and beneficial owner of the Trade Marks, details of which are set out in the Schedule hereto (hereinafter called "the Trade Marks");

AND WHEREAS

The Assignor has agreed with the Assignee to assign and transfer absolutely to the Assignee all right, title and interest in and to the Trade Marks for the consideration hereunder mentioned;

NOW THEREFORE THIS ASSIGNATION WITNESSETH AS FOLLOWS:

1. that the Assignor, in consideration of the sum of £50,000.00 (Fifty Thousand Pounds Sterling) and other good and valuable consideration, receipt of which is hereby acknowledged, hereby, with full title guarantee, assigns unto the Assignee
 - 1.1 all that property, right, title and interest in and to the Trade Marks including all common law rights connected therewith together with the goodwill of the business relating to the goods in respect of which the Trade Marks are registered and used;
 - 1.2 all of its rights to bring proceedings and seek remedies for any infringement of such Trade Marks which may have occurred prior to the date hereof;
 - 1.3 to the extent that such rights exist and are not already assigned hereby all of its right, title and interest in or to the Trade Marks existing at common law by virtue of its use thereof;

- 1.4 to the extent that such rights exist and are not already assigned hereby all of its rights to institute and maintain proceedings for passing off or equivalent proceeding; against any person now or hereafter wrongfully using the Trade Marks; and
- 1.5 to the extent that such rights exist and are not already assigned hereby, all of its rights if any to file applications corresponding to the trade mark applications hereby assigned (if any) and to claim priority from those applications

TO HOLD same unto the Assignee and its assigns absolutely and the assignee hereby accepts and receives the same.

- 2. The Assignor warrants and represents that this Assignment is the first and only transaction instrument or act of any kind entered into or effected by the Assignor in disposition of the Trade Marks and the appurtenant rights hereby assigned.
- 3. At the request and sole cost of the Assignee, the Assignor shall:
 - 3.1 do everything reasonably in its power to assist the Assignee in the defence of any proceedings by way of opposition to the registration of the Trade Marks;
 - 3.2 execute all such further documents, forms and authorisations and depose or swear any declaration or oath as may be required by the Registrar of Trade Marks for absolutely vesting full right, title and interest in and to any registration of the Trade Marks in favour of the Assignee.
- 4. This Assignment and its terms shall be governed by and construed in accordance with the Laws of Scotland and the parties irrevocably agree that the Courts of Scotland are to have jurisdiction in relation to any disputes which may arise out of or in connection with this Assignment.


