ASSIGNMENT OF REGISTERED TRADEMARKS

CSK Auto, Inc., an Arizona corporation having a business address of 645 East Missouri Avenue, Phoenix, Arizona 85012, and PACCAR Inc, a Delaware corporation having a business address of 777 106th Avenue Northeast, Bellevue, Washington 98004, entered into a Stock Purchase Agreement dated as of August 20, 1999. PACCAR agreed to sell to CSK all of the issued and outstanding shares of stock of PACCAR Automotive, Inc.

The Stock Purchase Agreement (Schedule 1.12.9) excluded the trademarks named below from the assets assumed by CSK upon closing of the Stock Purchase Agreement and prohibited CSK's use of the trademarks.

1. DYNACRAFT - No. 2,148,708 filed August 16, 1996 by PACCAR Automotive, Inc. and registered April 7, 1998 for use on hand tools, namely sockets, pliers, wrenches, bits, screwdrivers, socket sets, ratchets, socket rails, adapters, extensions, creepers and lift equipment, in Class 8.
2. DYNACRAFT - No. 2,019,022 filed September 25, 1995 by PACCAR Inc; registered November 26, 1996 for use on spark plug wires in Class 7 and drive belts for land vehicles in Class 12; assigned to PACCAR Automotive, Inc. on January 24, 1997 and recorded by the Assignment Division of the U.S. Patent and Trademark Office 2/10/1997 at Reel/Frame 8345/04580.

The Stock Purchase Agreement closed October 1, 1999. Article 9.1 of the Agreement obligates CSK to take whatever actions are necessary or useful to transfer to PACCAR any portion of the excluded assets which may be in or come into CSK's possession at any time after the Closing.


PACCAR, through its Dynacraft and Parts Divisions, continues to use the DYNACRAFT trademarks on the goods for which they are registered except for goods in Class 7.

CSK and PACCAR wish to correct the records of the United States Patent and Trademark Office as to the ownership and use of DYNACRAFT Trademarks 2,019,022 and 2,148,708.

Now, therefore, for good and valuable consideration, receipt of which is hereby acknowledged, CSK Auto, Inc. does hereby assign unto PACCAR Inc all right, title and

interest in and to Trademarks 2,019,022 and 2,148,708, together with the good will of the business symbolized by the mark, and the above identified registrations thereof.


