**THIS TRADEMARK RELEASE** is made this 26<sup>th</sup> day of June, 2002, by **THE CIT GROUP/COMMERCIAL SERVICES, INC.** (the "Secured Party") in favor of **PERFECT FIT INDUSTRIES, INC.**, a Delaware corporation (the "Grantor");

WITNESSETH:

WHEREAS, on August 1, 1996, the Grantor and the Secured Party executed a Trademark Security Agreement (the "Security Agreement"), which was recorded on September 9, 1996 at Reel 1500, Frame 0820, in the United States Patent and Trademark Office, pursuant to which the Grantor granted the Secured Party a lien in and security interest upon certain trademarks and trademark applications of the Grantor as more particularly described therein; and

WHEREAS, the Secured Party, at the request of the Grantor, has agreed to release its lien in and security interest upon those trademarks and trademark applications set forth on Exhibit A attached hereto (the "Released Trademarks");


