**RELEASE AND REASSIGNMENT OF TRADEMARKS**

THIS RELEASE AND REASSIGNMENT dated July 11, 2002 by Harris Trust and Savings Bank, as collateral agent as hereinafter described;

**WITNESSETH:**

WHEREAS, Harris Trust and Savings Bank, an Illinois banking corporation with its mailing address at 111 West Monroe Street, Chicago, Illinois 60690 (hereinafter referred to as "*Harris*"), for itself and as collateral agent hereunder for the Secured Creditors (as hereinafter defined) (Harris acting as such collateral agent being hereinafter referred to as "*Agent*"), and TDC Filter Manufacturing, Inc. (ii) each trademark license listed on Schedule A-2 hereto and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums.
