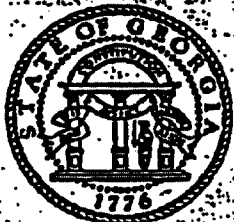

**ARTICLES OF AMENDMENT
OF
U.S. FILTER DISTRIBUTION SYSTEMS, INC.**

**To the Secretary of State
State of Georgia**

Pursuant to Section 14-2-1006.1 of the Georgia Business Corporation Code, the corporation named herein (the "Corporation") does hereby adopt the following Articles of Amendment.

1. The name of the Corporation is: U.S. Filter Distribution Systems, Inc.
2. Article I of the Articles of Incorporation of the Corporation is hereby amended by deleting in its entirety Article I thereof, and substituting therefor the following provisions so that, as amended, said Article shall be and read in its entirety as follows:
