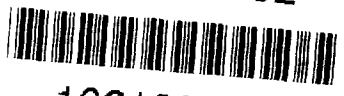

## RELEASE AND REASSIGNMENT

THIS RELEASE AND REASSIGNMENT is executed as of July 1, 2002 by **FOOTHILL CAPITAL CORPORATION**, a California corporation ("Foothill").

### WITNESSETH:

WHEREAS, **LANIER HEALTHCARE, LLC**, a Delaware limited liability company ("Debtor"), and Foothill are parties to that certain Trademark Security Agreement, dated as of March 30, 2001, pursuant to which Debtor incurred certain liabilities to and granted a security interest in and collateral assignment of the "Trademark Collateral" (as defined in the Agreement), including, without limitation, the trademark registrations and applications for trademark registration issued thereon or applied for in the United States or throughout the world, including registrations, recordings, supplemental registrations and pending applications for registration in the United States Trademark Office (collectively, the "Registrations") as described in Schedule A attached hereto, as security for Debtor's obligations to Foothill under the Agreement;

WHEREAS, the Agreement was submitted for recordation with the United States Trademark Office on or about April 6, 2001; and

WHEREAS, Debtor has satisfied its obligations under the Agreement and has requested that Foothill release its security interest in the Trademark Collateral and reassign the same to Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Foothill hereby releases, without any representation, warranty, or recourse whatsoever, its security interest in and collateral assignment of the Trademark Collateral.

2. Foothill hereby reassigns, grants and conveys to Debtor, without any representation, warranty, or recourse whatsoever, all of Foothill's right, title and interest, if any, in and to the Trademark Collateral, including without limitation all of the Registrations appearing in Schedule A.




