TRADEMARK ASSIGNMENT

The Assignor expressly agrees, upon the written request of the Assignee, to execute, acknowledge and deliver, such documents and other instruments that the Assignee may consider to be required to evidence or effectuate the sale, conveyance, assignment, transfer and delivery of the Mark to the Assignee.
