Pursuant to §§14-2-1001 and 14-2-1002 of the Georgia Business Corporation Code (the "Code"), Isolyser Company, Inc., a Georgia Corporation, hereby submits these Articles of Amendment:

1. The name of the corporation is:

"Isolyser Company, Inc."

2. The Articles of Incorporation of the Corporation are hereby amended by deleting the present Article I in its entirety and substituting the following in lieu thereof:

"ARTICLE I

NAME

The name of the corporation shall be: Microtek Medical Holdings, Inc."

3. The foregoing Amendment was duly adopted by the Board of Directors of the Corporation on May 22, 2002, without shareholder approval.


4. Pursuant to §14-2-1002 of the Code, shareholder approval was not required.

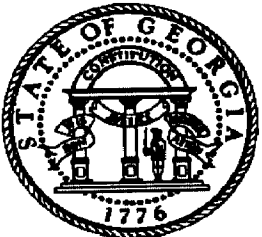
