WHEREAS, it is desired that the Assignment of the Mark, Nunc Pro Tunc, be made of record in the United States Patent and Trademark Office.

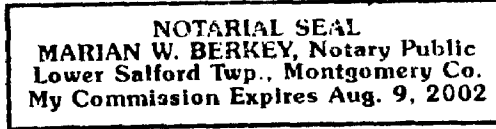
