TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "**Agreement**"), between Richard A. Marshack, solely in his capacity as trustee of the bankruptcy estate of NowDocs, Inc., and not in his individual capacity ("**Trustee**"), and Taylor Corporation, a Minnesota corporation located at 1725 Roe Crest Drive, North Mankato, Minnesota 56002 ("**Company**"), is executed on September 24, 2002. NowDocs, Inc., a California corporation, was located at 65 Enterprise, Aliso Viejo, California 92656.

RECITALS

- A. Trustee is the trustee of the bankruptcy estate of NowDocs, Inc., the owner of the trademarks and service marks listed on **Schedule A** (the "**Marks**").
- B. Trustee, on behalf of the Estate, hereby assigns the Marks to Company pursuant to the Asset Purchase Agreement between Assignor and Company dated August ____, 2002 in the Chapter 7 case number 02-14379, pending before the United States Bankruptcy Court for the Central District of California (the "**Agreement**"). All capitalized terms used but not otherwise defined herein have the meanings given them in the Agreement.

AGREEMENT

In consideration of the above recitals and the promises set forth in this Agreement, the parties agree as follows:

Trustee, on behalf of the Estate, transfers and assigns to Company all of the Estate's right, title and interest, if any, in and to the Marks, together with all associated good will and all related rights, and all registrations and applications for registration of the Marks in the United States and any foreign countries, including any renewals and extensions of any registration that is or may be secured. The provisions of this Agreement inure to the benefit of Company, its successors, assigns and other legal representatives, and are binding upon the Estate, its successors, assigns and other legal representatives.
