


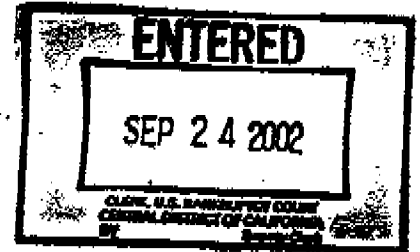
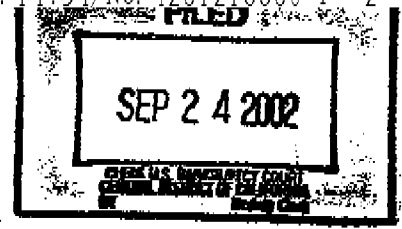

1 Thomas H. Casey of the Law Office of Thomas H. Casey, Inc. appeared on behalf of the
2 Trustee. Other appearances are reflected on the Court's record. The Court having considered the
3 Motion, proper notice having been given and good cause having been shown:

4 **IT IS HEREBY ORDERED** that the Trustee's Motion is granted as follows:

5 1. The sale of the Personal Property (as defined in the Motion) to Taylor
6 Corporation as proposed in the Motion pursuant to 11 U.S.C. Section 363, free and clear of all liens,
7 claims, interests, liabilities and encumbrances (including any and all "interests" in the Personal
8 Property within the meaning of 11 U.S.C. Section 363(b) and (f)) is approved;

9 The Purchase Agreement (as defined in the Motion) is approved and the Trustee is authorized to
10 execute, deliver, perform under, consummate and implement the Purchase Agreement;

11 2. The Trustee is authorized to sign any and all documents necessary, and to
12 undertake any non-material amendments and modifications necessary, to complete the sale of the
13 Personal Property to Taylor Corporation as proposed in the Motion without further notice, hearing
14 or Court order;

15 3. Any disputed liens, interests or encumbrances on or in the Personal Property
16 or any of it shall attach to the proceeds of the sale of the Personal Property with the same validity,
17 extent, priority and perfection that they attached to the Personal Property or any of it;

18 4. The overbid procedures set forth on Schedule 4.3 to the Purchase Agreement
19 are approved;

20 5. The Purchase Agreement was proposed by Taylor Corporation and the Trustee
21 in good faith and represents the highest and best offer for the Personal Property;

22 6. Taylor Corporation is a good faith purchaser under and entitled to the
23 protections of 11 U.S.C. Section 363(m);

24 7. Taylor Corporation will not assume or be liable for any liability of the Trustee,
25 the Debtor's bankruptcy estate or the Debtor (each a "Liability"), and has no successor




