



Jennifer Deckard, Treasurer of Fairmount Abrasives, Inc. (the "Corporation"), an Ohio corporation, does hereby certify that, in a writing approved and signed by the sole shareholder of the Corporation as permitted by Section 1701.54 of the Ohio Revised Code, the following resolutions to amend the Articles of Incorporation of the Corporation were adopted effective December 12, 2000:

RESOLVED: That Article I of the Articles of Incorporation of Fairmount Abrasives, Inc. be and it hereby is amended to read in its entirety as follows:

"ARTICLE I

The name of the corporation is Fairmount Custom Products, Inc."
