WHEREAS, Lender wishes to release, retransfer and reassign to Grantors, without representation or warranty, all of Lender's right, title and interest in and to the Marks and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lender hereby releases, retransfers and reassigns to Grantors, without representation or warranty, all of Lender's right, title and interest in and to the Marks and the goodwill associated therewith.
