**RELEASE AND REASSIGNMENT OF
TRADEMARKS AND TRADEMARK APPLICATION/REGISTRATIONS**


Reference is hereby made to that certain Security Agreement dated as of June 13, 1997, executed by VIBE/SPIN VENTURES LLC, a Delaware limited liability company (the "Borrower"), SPIN VENTURES LLC, a wholly owned subsidiary of the Borrower, and VIBE VENTURES LLC, a wholly owned subsidiary of the Borrower (each, a "Guarantor" and collectively, the "Guarantors"; the Guarantors and the Borrower are referred to collectively herein as the "Grantors"), in favor of SALOMON BROTHERS INC, a Delaware corporation, as collateral agent and administrative agent ("Lender"), which was recorded in the United States Patent and Trademark Office on November 20, 1997, at Reel 1658, Frame 0064 and pursuant to which Grantors assigned and granted to Lender a security interest in and to all of Grantors' right, title and interest in and to certain trademarks, including those trademarks specifically listed on Exhibit A attached hereto (the "Marks") and the goodwill associated therewith; and

WHEREAS, Lender wishes to release, retransfer and reassign to Grantors, without representation or warranty, all of Lender's right, title and interest in and to the Marks and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lender hereby releases, retransfers and reassigns to Grantors, without representation or warranty, all of Lender's right, title and interest in and to the Marks and the goodwill associated therewith.
