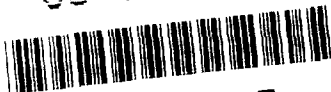


FIRST: The name of the Limited Partnership is The ALLTEL Alabama Limited Partnership.
