2. Article I of the Corporation's Amended and Restated Articles of Incorporation, which presently reads as follows:

"The name of the Corporation is Precis Design Corporation (the "*Corporation*")."  
shall be amended to read as follows:

"The name of the Corporation is Raycom Technologies, Inc. (the "*Corporation*")."

3. The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the Board of Directors of the Corporation.

4. The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the required vote of the shareholders of the Corporation in accordance with Sections 902 and 903 of the California Corporations Code. There are currently outstanding 3,500,000 shares of Common Stock and 1,500,000 shares of Series A Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required, such required vote being more than 50% of the total number of outstanding shares of Common Stock and 50% of the total number of outstanding shares of Series A Preferred Stock.
