Reference is made to the Purchase Agreement ("Agreement") dated August 14, 2000 between Forest Pharmaceuticals Inc. ("Forest") and Vintage Pharmaceuticals, Inc. ("Vintage"). By this letter, we confirm that Vintage has satisfied its payment obligations under the above referenced Agreement and accordingly Forest no longer has a security interest in the assets purchased pursuant to the Agreement.

Simultaneously with the mailing of this letter, Forest has filed a UCC-3 Financing Statement Amendment in Alabama which terminates the UCC-1 financing statement filed on September 29, 2000. A copy of the UCC-3 termination statement is enclosed for your records.
