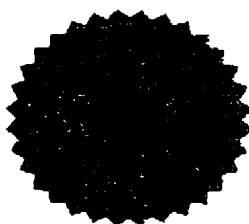

FIRST: The name and state of incorporation of each of the constituent corporations that is a party to the Merger are as follows:
