TRADEMARK AND GOODWILL ASSIGNMENT

Dated 28 May 2002 ^{2001.}

Parties:

- (1) **MECO CONVEYORS LIMITED**, a company incorporated in England and Wales (registered no. 00832053, whose registered office is at Mecco Works, Bromyard Road, Worcester WR2 5EG, (the "**Assignor**"); and
- (2) **JOY MINING MACHINERY LIMITED**, a company incorporated in England and Wales (registered no. 02546087), whose registered office is at Bromyard Road, Worcester WR2 5EG ("**JMM**").

Recitals:

- (A) The Assignor has adopted, used, is using and is the registered proprietor of various registered trademarks and registered service marks and the registrations therefore as identified in the schedule attached hereto (the "**Registered Trade Marks**"); and
- (B) JMM is desirous of securing, and Assignor is desirous of granting to JMM, an assignment of the Registered Trade Marks, trade marks and service marks for which applications for registration have been filed and the applications as identified in the schedule attached hereto (the "**Applications**"), and all names, logos and other unregistered marks which include, comprise of or are similar to any of the Registered Trade Marks or Applications (the "**Unregistered Trade Marks**", the Registered Trademarks, the Applications and the Unregistered Trade Marks together the "**Trade Marks**"), as well as the goodwill developed and established, symbolized and associated in connection with the Trade Marks.

Operative provisions:

1. **Assignment**

In consideration of the sum of one pound Sterling (£1) now paid by JMM to the Assignor, receipt of which Assignor does hereby acknowledge, Assignor hereby assigns and transfers to JMM absolutely:

- (i) all of its right, title and interest in and to the Trade Marks including all statutory and common law rights attaching to the Trade Marks and all rights, powers, privileges, liberties and immunities attaching to the Trade Marks, free from all liens, charges and encumbrances (other than as created pursuant to a debenture dated 5 July 2001 in favour of The Law debenture Trust Corporation p.l.c. (as amended varied or supplemented from time to time);
- (ii) pursuant to clause 1(i), the benefit of any trademark or service mark granted pursuant to an Application with the intention that on registration JMM is entered on the register of trade marks as the registered proprietor of that registered trade mark;

- (iii) the right to sue for and recover damages and other remedies in respect of any infringement of or acts of passing off in respect of the Trade Marks which may have occurred before the date of this Assignment; and
- (iv) the goodwill attaching to the Trade Marks.

2. **Further Assurance**

The Assignor shall on request by JMM and at JMM's expense do and execute or arrange for the doing and executing of, each necessary act, document and thing reasonably within its power to implement this Assignment and give such assurance as JMM may reasonably request to complete the registrations of the trade marks and service marks pursuant to the Applications.

3. **Assistance With Proceedings**

If proceedings are instituted by way of claim, petition or counter-claim impugning the validity of the registration of a Registered Trade Mark or of a registration granted pursuant to an Application or opposing the grant of a registration pursuant to an Application the Assignor shall give all reasonable assistance to JMM in relation to those proceedings (including participation in proceedings) subject to the payment by JMM of all the Assignor's reasonable costs in relation to those proceedings.

4. **Governing Law**

This Assignment is governed by English law.

5. **Delivery**

This Assignment is delivered as a deed on the date written at the start of this Assignment.
