TRADEMARK TRANSFER AND ASSIGNMENT AGREEMENT

This Trademark Transfer and Assignment Agreement is made this 6th day of February, 2002, by and between PROFILE PURSUIT INC., a Delaware corporation, located at 51 East 42nd Street, 16th Floor, New York, New York 10017 (“Assignor”), and PROFILE PURSUIT GROUP LIMITED, a private company existing under the laws of the United Kingdom, located at The Interchange, Oval Road, London, England, United Kingdom NW1 7DZ (“Assignee”).

WITNESSETH:

WHEREAS, Assignor is the owner of the trademark “T MAGAZINE”, which is the subject of Registration No. 2,527,372 (International Class 16 for magazines in the field of golf), registered in the U.S. Patent and Trademark Office on January 8, 2002 (hereinafter referred to as the “Mark”); and

WHEREAS, Assignor wishes to grant, transfer and assign to Assignee, and Assignee desires to acquire the Mark from Assignor.

NOW THEREFORE, in consideration of the premises and mutual covenants, and intending to be legally bound hereby, the parties agree as follows:

1. Transfer of the Mark.

Assignee hereby agrees to provide notice of the transfer of the Mark to the U.S.


Patent and Trademark Office pursuant to all applicable federal requirements.

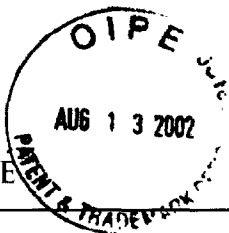

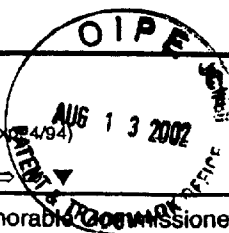
