## CONFIRMATORY SERVICE MARK ASSIGNMENT

This Confirmatory Service Mark Assignment (this "Assignment") is made on July 25, 2002 by and between **Gilbert P. Cohen**, an United States citizen, (hereinafter "Assignor") and **Water Water Everywhere, Inc.**, a Maryland corporation, (hereinafter "Assignee")

WHEREAS, the Assignor was the owner of all right, title and interest in and to the Mark WATER WATER EVERYWHERE and U.S. Service Mark Registration No. 1,672,205 (hereinafter "the Mark"); and


WHEREAS, Assignor was desirous of assigning, and Assignee was desirous of obtaining, all right, title and interest in and to the aforementioned Mark; and

NOW, THEREFORE, for good and valuable consideration previously paid, the sufficiency and receipt of which are hereby acknowledged, it is confirmed that effective as of Nov. 18, 1996, Assignor did assign, transfer and convey, and hereby nunc pro tunc assigns, transfers and conveys, unto Assignee, all right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark and U.S. Service Mark Registration No. 1,672,205, the same to be held and enjoyed by the Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this assignment and sale had not been made; together with all claims for damages by reason of past infringement by the Mark, with the right to sue for, and collect the same for its own use and on behalf of its own successors, assigns, or other legal representatives.
