TRADEMARK ASSIGNMENT

Assignor hereby authorizes and requests the United States Patent and Trademark Office in the United States and any and all foreign countries to issue any and all registrations, when granted, to said Assignee as the owner of the entire right, title, and interest in and to the same, for the sole use and enjoyment of said Assignee, its successors and assigns.

Further, Assignor agrees that he will communicate to said Assignee or its representatives, any facts known to him respecting said Trademark, and testify in any legal proceedings, sign all lawful papers and execute all necessary assignment papers to cause any and all of said registrations to be issued to said Assignee, make all rightful oaths, and generally do everything necessary or desirable to aid said Assignee, its successors and assigns, to obtain and enforce proper protection for said Trademark in the United States and in and all foreign countries.
