

RELEASE OF SECURITY INTEREST

This **RELEASE OF SECURITY INTEREST** ("Release") is given as of this 15th day of October, 2002 by Société Générale, a French banking corporation ("Soc Gen"), located at 1221 Avenue of the Americas, New York, NY 10020, in favor of Pro-Football, Inc., a Maryland corporation ("PFI"), located at 21300 Redskin Park Drive, Ashburn, VA 20147.

WHEREAS, pursuant to a Security Agreement, dated July 14, 1999, by and between Soc Gen, PFI and certain of PFI's affiliates (the "Security Agreement") and a Grant of Security Interest in Trademarks, dated July 13, 1999, by and between Soc Gen and PFI (the "Grant"), PFI conveyed to Soc Gen a security interest in the entire right, title and interest in and to its trademarks, including, without limitation, the trademark registrations and applications set forth on Schedule A attached hereto, and the goodwill associated with such trademarks (the "Trademarks"), which security interest was recorded in the United States Patent and Trademark Office on December 17, 1999 at Reel 002007/Frame 0956; and

WHEREAS, PFI has paid in full all of the obligations and all of the commitments have terminated in accordance with the Security Agreement, the Grant and any other related documents, and Soc Gen desires to release its security interest in and to the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Soc Gen hereby releases its security interest in the entire right, title and interest in and to the Trademarks and reassigns any and all right, title and interest that it may have in the Trademarks to PFI.
