ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT AGREEMENT is made effective as of August 1, 2000, between Dadco Diversified, Inc. WHEREAS, Assignor desires to assign to Assignee all of Assignor's right, title and interest in and to the Trademark and the goodwill associated therewith;

WHEREAS, this assignment is being made to Assignee as a successor of Assignor's business, or portion of the business, to which the Trademark pertain, and is consistent with the Purchase Agreement between the same parties dated August 1, 2000 which sale and assignment was subsequently authorized by the United States Bankruptcy Court, Western District of Wisconsin, by Order dated August 25, 2000.

NOW, THEREFORE, in consideration of the covenants contained herein and other good and valuable consideration, the sufficiency of which is hereby acknowledged, the parties hereto, intending to be legally bound hereby, agree as follows:

1. **Assignment.** Assignor hereby assigns, transfers and conveys to Assignee all of Assignor's right, title and interest in and to the Trademark, together with the business and goodwill of the business which is symbolized by the Trademark and the right to sue and recover any damages and profits and all other remedies for future infringements thereof.

2. **Binding Nature of Agreement.** This Assignment Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
