ASSIGNMENT AGREEMENT

THIS AGREEMENT is made and entered by and between Sandra G. Linver, an individual residing within the State of Georgia ("Assignor"), and Speakeasy, Inc., a Georgia corporation, having an office and principal place of business at Suite 600, Atlantic Center Plaza, 1180 West Peachtree St., Atlanta, Georgia 30309 ("Speakeasy" or "Assignee").

WHEREAS, Speakeasy has at all times since its formation been the exclusive user and the beneficial owner of the **SPEAKEASY** mark;

WHEREAS, Assignor has at all times been the sole shareholder, CEO and President of Speakeasy;

WHEREAS, Assignor wishes to assign, grant and deliver exclusively unto Assignee full right and title in and to the Speakeasy Registration together with all the goodwill of Assignor in and relating to the **SPEAKEASY** mark (including the Speakeasy Registration), and all rights of action in connection therewith and any claims for past infringement thereof; and


WHEREAS, Assignee is desirous of accepting said assignment;

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor assigns, grants and delivers to Assignee, and Assignee accepts, effective as of May 23, 1983, full right and title in and to the Speakeasy Registration together with the goodwill of Assignor in and relating to the **SPEAKEASY** mark (including the Speakeasy Registration), and all rights of action in connection therewith and claims for past infringement thereof.
