RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT dated August 6th, 2002 by Harris Trust and Savings Bank, as Agent as hereinafter described;

WITNESSETH:

A. Harris Trust and Savings Bank, an Illinois banking corporation, as Agent (the "Assignee"), with a mailing address of 111 West Monroe Street, Chicago, Illinois 60690, and Linden Oaks Corporation, a Delaware corporation (the "Assignor"), with a mailing address of 103 Foulk Road, Suite 290, Wilmington, Delaware 19803, are parties to a certain Trademark Collateral Agreement dated August 28, 2000, which was recorded in the United States Patent and Trademark Office on September 14, 2000, at Reel 002148, Frame 0530 (the "Agreement"), pursuant to which, among other things, the Assignor granted a security interest in and collateral assignment of its trademarks listed on Schedule A-1 attached hereto and certain other property described therein (collectively, the "Trademarks") as security for the indebtedness, obligations and liabilities described therein as well as security for the indebtedness, obligations and liabilities described in that certain Security Agreement Re: Intellectual Property dated September 23, 1998 among the Assignee, Assignor, Kennedy Endeavors, Incorporated, a Washington corporation and Linden Oaks Corporation, a Delaware corporation.

B. The Assignor has requested that the Assignee release its security interests in the Trademarks and reassign the same to the Assignor, and the Assignee is willing to do so on the terms and conditions herein set forth.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Assignee hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to the Assignor, without any representation, warranty, recourse or undertaking by the Assignee, all of its right, title and interest, if any, in and to:

(i) Each Trademark and each Trademark Application listed on Schedule A-1 attached hereto and made a part hereof, including without limitation all renewals thereof, all proceeds thereof (such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements thereof, and all rights corresponding thereto throughout the world; and

(ii) The goodwill of the business to which each of the Trademarks relates.
