WHEREAS, Assignor wishes to herein memorialize said assignment, transfer and assignment of the Trademarks to Assignee.



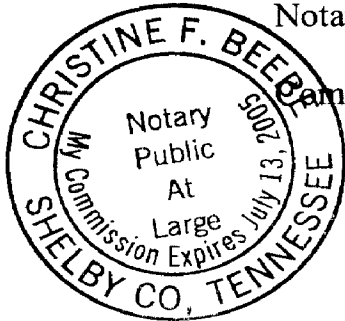
