FIRST: The Board of Directors of each of the constituent corporations has duly adopted a plan of merger setting forth the terms and conditions of the merger of said corporations.

SECOND: The name of the constituent corporation which is to be the surviving corporation, and which is hereinafter sometimes referred to as the "surviving constituent corporation", is THOMSON INFORMATION SERVICES INC. The date upon which its certificate of incorporation was filed by the Department of State is December 9, 1993, under the original name of MTI (NEW YORK) INC.


