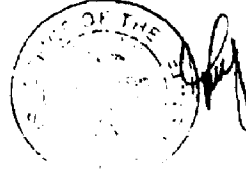

2. Article I of the Restated Articles of Incorporation of the Corporation is amended to read as follows:  


The name of the corporation is Emagia Corporation.
