

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

TERMINATION AND RELEASE, dated as of May 29, 2002, from TORONTO DOMINION (TEXAS), INC., as Collateral Agent (the "Secured Party"), to PAGING NETWORK, INC. (the "Pledgor"), a Delaware corporation.

WITNESSETH:

WHEREAS, a security interest (the "Security Interest") in certain Collateral (as hereinafter defined) was granted to Nationsbank of Texas, N.A., as Documentation Agent ("NationsBank"), and was recorded in the Trademark Division of the United States Patent & Trademark Office (the "USPTO") on the date and at the reel and frame as set forth on Schedule A; and

WHEREAS, the Security Interest was assigned by NationsBank to Bank of America as its successor in interest and was recorded in the Trademark Division of the USPTO on the date and at the reel and frame as set forth on Schedule A; and

WHEREAS, the Security Interest in the Collateral (as hereinafter defined) was assigned by Bank of America to The Bank of New York, as Collateral Agent and was recorded in the Trademark Division of the USPTO on the date and at the reel and frame as set forth on Schedule A; and

WHEREAS, the Security Interest in the Collateral (as hereinafter defined) was assigned by The Bank of New York, as Collateral Agent to Toronto Dominion (Texas), Inc. as Successor Collateral Agent, which assignment was recorded in the USPTO on the date and at the reel and frame as set forth on Schedule A; and

WHEREAS, the Secured Party now desires to terminate and release the entirety of its Security Interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Collateral, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party agrees as follows:

- right, title and interest of every kind and nature in and to the United States trademarks and service marks set forth on Schedule A attached hereto and (i) all registrations, applications, recordings and common-law rights relating thereto; (ii) all renewals thereof; (iii) all income, license royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past, present and/or future infringements thereof; (iv) the right to sue for past, present and future infringements thereof; (v) all rights corresponding thereto throughout the world; and (vi) the goodwill of Pledgor's business connected with and symbolized by the foregoing.
- 2. <u>Release</u>: The Secured Party hereby terminates and releases in its entirety the Security Interest in the Collateral.
- 3. <u>Recordation</u>: The Secured Party hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States to record this release of the Security Interest in the Collateral.

- 4. Further Assurance: The Secured Party hereby agrees to, at the sole expense of the Pledgor, duly execute, acknowledge, procure and deliver any further documents, including, but not limited to, those documents as may be necessary under Article 9 of the Uniform Commercial Code or other applicable law, and to do such other acts as may be reasonable necessary to effect the release of the Security Interests contemplated hereby.
- 5. Modification: This Termination and Release may not be modified, nor may any provision hereof be waived, orally or in any manner other than by an agreement in writing signed by the parties hereto or their respective successors or assigns.
