**AMENDED AND RESTATED
TRADEMARK SECURITY AGREEMENT SUPPLEMENT**

WORLD PUBLICATIONS, LLC ("World"), hereby supplements the Schedules attached to the Amended and Restated Trademark Security Agreement dated as of November 9, 2001 among WORLD PUBLICATIONS, LLC, WORLD SPORTS AND MARKETING, LLC, WORLD ENTERTAINMENT SERVICES, LLC, WORLD PUBLICATIONS HOLDING, LLC, WORLD PUBLICATIONS II, LLC, AND WORLD PUBLICATIONS III, LLC, and WACHOVIA BANK, NATIONAL ASSOCIATION, for itself and as an agent ("Agent") for certain lenders described in the Amended and Restated Trademark Security Agreement (the "Trademark Security Agreement"), with Schedule 1 attached hereto (the "Trademark and Security Agreement Supplement") and hereby agrees in favor of the Agent as follows:

Unless otherwise specifically defined herein, each term used herein which is defined in the Trademark Security Agreement shall have the meaning assigned to such term in the Trademark Security Agreement. Each reference to "hereof", "hereunder", "herein" and "hereby" and each other similar reference and each reference to "this Agreement" and each other similar reference contained in the Trademark Security Agreement shall from and after the date hereof refer to the Trademark Security Agreement as amended hereby.


The definition of "Trademark Collateral" contained in the Trademark Security Agreement is hereby amended to include the additional Trademarks ("Additional Trademark Collateral") described on Schedule 1 attached hereto. World hereby pledges, mortgages, and grants a security interest in and to the Agent, for itself and on behalf of the Lenders, all of its respective right, title and interest in and to the Additional Trademark Collateral, together with all monies and claims for monies now or hereafter due or payable thereon or in respect thereof, to secure the Secured Obligations.
