RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST made and entered into this 22nd day of April, 2002, by PNC BANK, NATIONAL ASSOCIATION ("PNC"), as Administrative Agent for the Banks, in favor of CHAMPION ENTERPRISES, INC. a Michigan corporation ("Borrower").

WHEREAS, Borrower, PNC and the Banks are parties to a certain Credit Agreement dated May 5, 1998, and Amendments thereto (the "Credit Agreement"), under which the Banks extended loans and other credit to the Borrower.
