TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, is dated as of July 15, 2002, by and between The CIT Group/Business Credit, Inc. (the "Secured Party"), and Sandusky Cabinets, Inc., a Tennessee corporation (the "Company").

WHEREAS, the Company with its principal place of business at 4815 Biloxi Street, Millington, Tennessee 38053, and the Secured Party entered into a Trademark Security Agreement (as amended and in effect from time to time, the "Security Agreement") dated as of March 28, 2001, which Security Agreement was recorded with the United States Patent and Trademark Office on May 30, 2001 at Reel 002350, Frame 0130 for the purpose of securing certain obligations of the Company to the Secured Party (the "Secured Obligations");

NOW, THEREFORE, for valuable consideration and pursuant to the terms and conditions set forth in the Security Agreement.

The Secured Party hereby terminates and releases its security interest in the Company's Trademarks, including without limitation the Trademarks identified on Exhibit A attached hereto, and the Secured Party hereby assigns and transfers to the Company, without recourse, all of the Secured Party's right, title and interest in and to the Trademarks, including without limitation the Trademarks listed on Exhibit A attached hereto, effective as of the date set forth above.

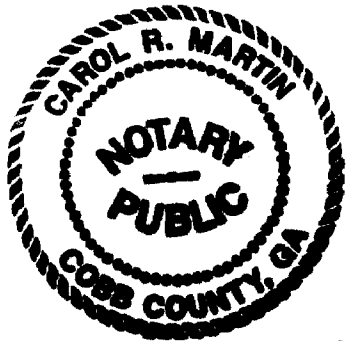




