Assignor hereby requests each registrar of trademarks whose duty it is to issue trademark registrations, to issue certificates of registration, renewal, or assignment, for any registration or application of the Trademarks to Assignee, its successors, and assigns, in accordance with the terms of this Assignment.

Assignor further agrees, without further consideration, to cause to be performed such lawful acts and to execute such further documents as Assignee may reasonably request to fully effectuate this Assignment including, but not limited to, the execution of assignments in recordable form in each jurisdiction where trademark registrations or applications for the Trademarks may be issued or pending.

Assignor hereby specifically disclaims any and all representations and warranties, express or implied (including without limitation any implied warranty of merchantability, fitness for a particular purpose, validity, registrability, or non-infringement and implied warranties arising from course of dealing or course of performance), regarding the Trademarks.
