



Interlee, Inc.


SECOND: Said amendment was duly adopted, in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.



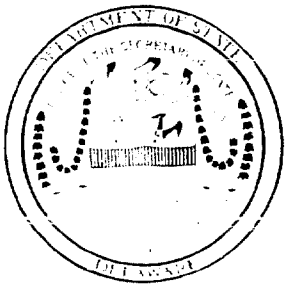
