**ARTICLES OF MERGER
OF
SENSOMATIC ELECTRONICS CORPORATION
(a Delaware corporation)
INTO
TYCO ACQUISITION CORP. XXIV (NV)
(a Nevada corporation)**

(Under the provisions of Chapter 92A of the Nevada Revised Statutes)

The constituent entities herein named do hereby adopt the following Articles of Merger (the

"Articles of Merger").

1. The name and jurisdiction of organization of each of the constituent corporations to the merger are:

- (a) Sensomatic Electronics Corporation, a Delaware corporation (the "Corporation"); and
- (b) Tyco Acquisition Corp. XXIV (NV), a Nevada corporation ("Acquirer").

2. The Agreement and Plan of Merger by and between Acquirer and the Corporation dated as of August 3, 2001, including a guarantee of Tyco International Ltd., a Bermuda company (as amended, the "Merger Agreement"), was adopted by the board of directors of the Acquirer on August 3, 2001 and was adopted on by the board of directors of the Corporation on August 2, 2001. Under Chapter 92A of the Nevada Revised Statutes, the approval of the sole stockholder of Acquirer is not required.

3. The Acquirer owns at least ninety percent (90%) of the outstanding shares of the common stock, \$0.01 par value per share, of the Corporation. This is the sole outstanding class of capital stock of the Corporation. The merger of the Corporation with and into Acquirer is permitted by the provisions of the Delaware General Corporation Law (the "DGCL") and has been approved and authorized in compliance with the DGCL.

4. When the merger herein provided for becomes effective, Acquirer will be the surviving corporation and Article FIRST of the Articles of Incorporation of Acquirer shall be deleted in its entirety and amended pursuant to the Merger Agreement to read as follows:

**"ARTICLE I
NAME OF CORPORATION**

The name of the Corporation is Sensomatic Electronics Corporation."

5. The executed Merger Agreement is on file at the principal place of business of Acquirer. The principal place of business of Acquirer is c/o Tyco International (US) Inc., One Tyco Park, Exeter, New Hampshire 03833.

6. The merger herein provided for between the Corporation and Acquirer shall become effective in the State of Nevada immediately upon the filing of the Articles of Merger on November 13, 2001.

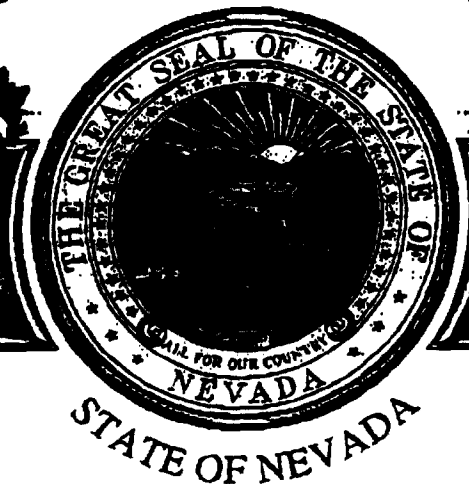

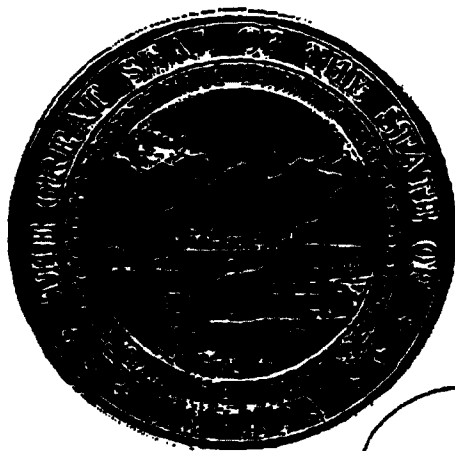
